

# **Sawnee EMC Commercial Lighting/Equipment Upgrade Rebate**

## **Summary:**

A Sawnee EMC member, billed under a commercial rate schedule, can apply for a rebate for upgrading the lighting and/or a piece of production equipment at their facility within the current year. The upgraded lighting or equipment must meet the requirements listed below. If these requirements are met, the commercial member will be eligible for a rebate credit of 1/4 of the total cost of the installation up to a maximum of \$750.00. The rebate will be applied as a credit on the next monthly bill following verification of the upgrade. Please read the following requirements:

## **Requirements**

- The upgraded lighting must be Energy Star Certified, or if LED, have documentation showing that it has been tested according to Illuminating Engineering Society LM-79, LM-80, with TM-21 calculated. Documentation that shows this information, must be submitted with the application. Lighting that does not meet these guidelines is not eligible.
- The upgraded production equipment must be replacing a working piece of equipment. The rebate does not apply to replacement of no longer working equipment.
- The total cost estimate of the project must be submitted with this application. A return on investment (ROI) based solely on kilowatt hour (kWh) savings will be calculated based on kWh history for the account. Kilowatt hour savings alone must pay for project in less than 5 years.

- The application will be reviewed and you will be contacted to set up an initial meeting with the Commercial Marketing Representative to verify existing conditions.
- All work can be completed after existing conditions are verified and the proposed changes are approved.
- Contact the Marketing Representative for the final inspection after all work is completed.
- After the final inspection is complete and the changes are verified to reduce monthly kilowatt consumption for the applicant, credit will be applied to the member's account in the amount of 1/4 of total cost up to \$750 maximum. Copies of final receipts or invoices for the upgrade must be available at the time of the final inspection.

When recommended by a Sawnee EMC Marketing Representative, a member can receive a one time energy grant to assist in the installation of lighting or replacement of a piece of production equipment that will result in a measurable reduction of kilowatt usage for the member.
