COMMERCIAL ELECTRIC VEHICLE (CEV) CHARGING STATION SERVICE

SCHEDULE CEV-5

I. AVAILABILITY

Available within the territory served by the Cooperative, in accordance with the Service Rules and Regulations.

II. APPLICABILITY

Applicable to consumers for service to separately metered, stand-alone electric vehicle charging stations with an initial connected load of 2,000 kW or less.

III. CONDITIONS OF SERVICE

A. The consumer shall make a one-time selection of either;

1. Option 1 - A contribution in aid of construction equal to 100% of the cost of dedicated local facilities installed by the Cooperative, plus a monthly Facilities Charge of **1.38%** of the dollar investment in local facilities installed by the Cooperative. Local facilities include transformers, secondary and service facilities, and the meter; **or**
2. Option 2 - A contribution in aid of construction equal to zero (\$0), plus a monthly Facilities Charge of **1.97%** of the dollar investment in local facilities installed by the Cooperative. Option 2 is only available to accounts taking initial service after March 4, 2024.

B. An audit of the facilities interconnected may occur at any time to verify that only EV charging load is connected to this service.

IV. TYPE OF SERVICE

Three-phase, 60 hertz, at available secondary voltages.

V. RATE - MONTHLY

A. Base Charge: @ \$47.00 per month

B. Facilities Charge: As defined in the preceding Section III.A.1. or III.A.2. Dedicated transformer cost will be estimated where service is from an existing transformer of greater required capacity or is used for service to other consumers.

VI. MINIMUM CHARGES

The minimum monthly charge shall be the A.) Base Charge, plus B.) Facilities Charge.

VII. WHOLESALE POWER COST ADJUSTMENT

The above rates shall be increased or decreased subject to the provisions of the Corporation's Wholesale Power Cost Adjustment Schedule "R".

VIII. DETERMINATION OF ON-PEAK AND OFF-PEAK ENERGY

- A. Critical-Peak Energy shall be classified as kilowatt-hours used from 2:00 p.m. until 8:00 p.m. during the billing months of June through August.
- B. On-Peak Energy shall be classified as kilowatt-hours used from noon until 10:00 p.m. during the billing months of May through September, excluding Critical Peak Energy.
- C. Off-Peak Energy shall be classified as the kilowatt-hours recorded during all other hours.

IX. FRANCHISE FEE, GROSS RECEIPT OR OCCUPATION TAX

Any tax or franchise fee, gross receipt or occupation tax imposed by any governmental authority upon the service, or any component thereof, rendered under this Schedule will be added to bills calculated pursuant to the above rate.

X. TERMS OF PAYMENT

The bill is due upon receipt and payable within ten (10) days thereafter.

XI. ADDITIONAL ADJUSTMENTS AND RIDERS

The bill calculated at the above rate is subject to change as may be determined under the provisions of the Corporation's Service Rules and Regulations or upon action by Sawnee EMC's Board of Directors, including but not limited to termination of this schedule.
